Organisational Structure

West Stormont Woodland Group committee, which includes the charity's trustees, is responsible for the day to day running of the SCIO and controlling and recording all financial transactions. Trustees are elected at the annual general meeting and at any one time there must be between a minimum of 3 and a maximum of 10 trustees.

Charitable Purpose

The SCIO has been formed to benefit the community of people living in or registered to vote in the postcode areas of PH1 3, PH1 4 and PH8 0 surrounding Taymount and Five Mile Woods within the boundary defined therein by West Stormont Woodland Group with the following purposes:

The advancement of environmental protection or improvement.

The provision of recreational facilities or the organisation of recreational activities with the object of improving the conditions of life for the persons for whom they are primarily intended.

The advancement of citizenship and community development.

Any other purpose that may reasonably be regarded as anologous to any of the preceeding purposes.

Independent Examiner's Report to the Trustees of West Stormont Woodland Group

I report on the financial statements of the charity for the period ended 31 March 2023, which are set out on pages 4 to 5.

Respective responsibilities of Trustees and Examiner
